"The church is the pioneer in displaying the implications of God's kingdom of peace brought in Jesus Christ. She does so by a relentless questioning of every aspect of her life as we learn slowly what it means to be a people of peace in every aspect of our existence" (Stanley Hauerwas, The Peaceable Kingdom, 132).

Opening Discussion: Just War Theory

Augustine (354-430 AD) | Thomas Aquinas (1225-1274 AD) Ensures that war is morally justifiable through series of criteria.

2 Major Emphases

- i) Law to War (ius ad bellum)
 - 1) Defensive (Self-defense)
 - -Intended to keep people safe
 - -Not for acquisition nor retribution
 - 2) Intention is peace

-The goal is to bring back peace.

- 3) Proportionate to the End Sought
 - -Is the price paid worth the end sought?
- 4) Last resort

-All diplomatic avenues are exhausted

- 5) Reasonable expectation of success (cf. Luke 14:31-32)
- ii) Law in War (ius in bella)
 - 1) Proportionality

-Employ the appropriate amount/type of force needed to achieve ends -Don't overdo it.

2) Discrimination

-No civilians attacked ('noncombatants')

-The Naked Public Square

"The truly naked public square is at best a transitional phenomenon. It is a vacuum begging to be filled. When the democratically affirmed institutions that generate and transmit values are excluded, the vacuum will be filled by the agent left in control of the public square, the state. In this manner, a perverse notion of the disestablishment of religion leads to the establishment of the state as church. Not without reason, religion is viewed by some as a repressive imposition upon the public square. They would cast out the devil of particularist religion and thus put the public square in proper secular order. Having cast out the one devil, they unavoidably invite the entrance of seven devils worse than the first" (Neuhaus, 86).

"And whatever the intention, because the naked square cannot remain naked, the direction is toward the stateas-church, toward totalitarianism" (Neuhaus, 89).
